<u>Bridging the gap: unveiling key links between autism and anxiety symptoms in autistic children and youth using a network analysis in pooled data from four countries</u>

Autistic children experience significantly higher rates of anxiety compared to nonautistic children. The precise relations between autism characteristics and anxiety symptoms remain unclear in this population. Previous work has explored associations at the domain level, which involve examining broad categories or clusters of symptoms, rather than the relationships between specific symptoms and/or individual characteristics. We addressed this gap by taking a network approach to understand the shared structure of autism characteristics and anxiety symptoms.

<u>Measurement of Anxiety and Depression Among Autistic Adults: Concordance Between</u>
<u>Diagnostic and Screening Instruments in a Feasibility Study</u>

The current study aims to report on the concordance between the PHQ-9, GAD-7, Adult Self Report (ASR), Anxiety and Related Disorders Interview Schedule for DSM-5 (ADIS-5), and best estimate clinical diagnosis (BECD) among autistic adults.

<u>Health Care Professionals' Experiences Regarding Facilitators of and Barriers to Sustained Use of Social Robot Ivy for People With Intellectual Disabilities: Qualitative Interview Study</u>

Labor shortages in health care pose significant challenges to sustaining high-quality care for people with intellectual disabilities. Social robots show promise in supporting both people with intellectual disabilities and their health care professionals; yet, few are fully developed and embedded in productive care environments. Implementation of such technologies is inherently complex, requiring careful examination of facilitators and barriers influencing sustained use.
