[Learning from Lives and Deaths – people with a learning disability and autistic people \(LeDeR\)](#)

LeDeR summarises the lives and deaths of people with a learning disability and autistic people who died in England in annual reports. The reports are made by researchers at King's College London collaborating with academic partners at the University of Lancashire and Kingston University London.

[Learning disabilities and adolescent suicidal ideation: Findings from the z-proso cohort study](#)

Objective: To investigate suicidal ideation among adolescents with learning disabilities and examine whether learning disabilities and a range of risk and protective factors assessed at age 13 are associated with suicidal ideation at age 15.

[Autistic traits and suicidality in midlife and old age: investigating mediating effects of mental health and social connectedness](#)

Suicidality is increased among middle-aged and older autistic adults, but little is known about the underlying factors linking autism with suicidality in midlife and older age.

[Life expectancy of people with intellectual disability: a retrospective cohort study from New South Wales, Australia](#)

To comprehensively analyse the life expectancy at birth of people with intellectual disability, including people with Down syndrome, to inform health equity and service planning.

[Barriers and facilitators to healthcare access for adults with learning disabilities and autistic adults in England: A scoping review and meta-aggregation](#)

Adults with learning disabilities and autistic adults in England face significantly higher rates of premature mortality, 22 years earlier for those with learning disabilities and over 6 years earlier for autistic adults.

[Caregiver-reported social impacts in down syndrome regression disorder](#)

Down Syndrome Regression Disorder (DSRD) is an acute neurocognitive regression in individuals with Down syndrome (DS), causing a profound loss of acquired skills. DSRD increases demands on caregivers, to sleep disturbances, financial distress, and negative impacts on caregiver-reported social connections and perceived social support.

[Association between intellectual disability and autism spectrum disorder with kidney failure](#)

Evidence regarding the risk of incident kidney failure based on developmental disabilities remains scarce. Accordingly, we examined the risk of kidney failure in individuals with intellectual disability (ID) and autism spectrum disorder (ASD).

[The relationship between age of autism diagnosis and life satisfaction in adulthood](#)

This study examined how age of autism diagnosis relates to adult life satisfaction in a sample of 769 self-reporting autistic adults.

[Sleep and Behaviour in Early Autism: Examining Bidirectional Associations Near Diagnosis](#)

Sleep problems and behavioural challenges are examined rarely in very young autistic children.

[The Role of Demographic and Autism Specific Factors on the Level of Depression in Autistic Adults](#)

Autistic adults often face co-occurring depressive symptoms. While previous studies have focused primarily on depression in children with autism, this study aims to investigate the factors associated with depressive symptoms in autistic adults.

[Communicative Behaviors in an Internet-Based Intervention for Individuals With Autism: Mixed Methods Analysis](#)

To meet the needs of individuals diagnosed with autism, internet-based interventions have been developed with a variety of objectives. A deeper understanding of the mechanisms of change may help tailor interventions to individual needs. The communicative behaviors of individuals with autism participating in text-based internet-based interventions remain largely unexplored, as do their potential relations to clinical outcomes. An improved understanding of participants' behaviors may help therapists better tailor support, promote engagement, and enhance treatment outcomes.

[Equitable inclusion of people with disabilities in clinical trials: a scoping review](#)

People with disabilities are underrepresented in clinical trials, which impacts generalisability and ethical integrity of results. Despite international mandates to diversify participants, there is a lack of guidance on how to make trials disability-inclusive. This scoping review identifies and synthesises guidance, practices and recommendations supporting the inclusion of people with disabilities in clinical trials.

[Emotional Contagion and Autistic Traits: Disentangling Components of Social-Emotional Processing](#)

Emotional contagion, the automatic sharing of another person's affective state, is a foundational component of social-emotional processing. Despite extensive research on empathy in autism spectrum disorder (ASD), little is known about automatic affective mechanisms and their relation to autistic traits.

[Advancing Healthcare Provision to Autistic Clients: A Systematic Review of Autism Focused Digitally Delivered Professional Education Programs \(DDPE\) for the Health Workforce](#)

Autistic individuals experience substantial inequities in healthcare access and outcomes, partly due to limited autism knowledge and training among healthcare professionals (HCPs). This systematic review aims to identify and critically analyze empirical evaluations of autism focused digitally delivered professional education (DDPE) programs for HCPs.
