[Moderating effect of avoidance on the relationship between depression and suicidal ideation across different types of trauma exposure](#)

These findings underscore the relevance of targeting avoidance symptoms to mitigate suicidal ideation, particularly in individuals with late-onset, single-incident or non-interpersonal trauma exposure. Exposure-based therapeutic interventions may offer particular benefit for reducing suicidal ideation among trauma-exposed individuals with depressive symptoms.

[Stigma and risk of self-injury and suicidality in adults with Tourette syndrome: findings from a cross-sectional impact survey](#)

This sample of ATS, on average, endures medium-high levels of stigma, which significantly contributes to their risk of self-injury, suicidal ideation and suicidal behaviours. Given this heightened risk, it is crucial to integrate stigma reduction interventions into health and mental health services for this vulnerable population.

[Lack of mental health beds contributed to UK teenager's death, inquest finds](#)

A shortage of mental health beds and poor communication between agencies contributed to the death of a teenage girl on hospital grounds, an inquest has found. Ellame Ford-Dunn, 16, who had a history of self-harm, died in March 2022 after absconding from an acute children's ward where she had been put because of a dearth of appropriate mental health beds.

[Using AI for emotional support](#)

Although AI can enable self-help, many are using it as a form of therapy or a substitute for other sources of emotional support. This can lead to growing reliance on it for their mental wellbeing. More worryingly, we know that chatbots can sometimes give harmful advice and encourage self-harm or suicide. Tragically, there have been cases where people have taken their own lives following advice provided by a chatbot.
